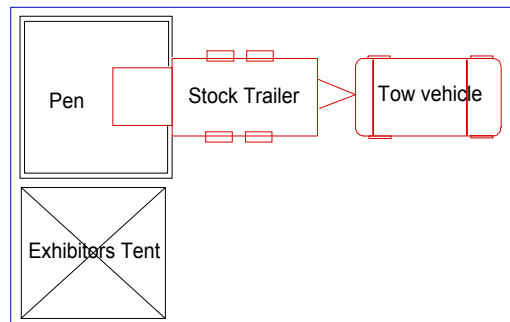
Space Allocation

The 'Wool Market' exhibition is taking place at Bicton College in the Paddock opposite the No. 1 Marquee on the Cedar Lawn. It will be on grass under a canopy of large trees.

The objective of this section of FibreFest is to display a large range of live fibre producing animals and their recently shorn fleeces (given that in August most won't have much fleece re-growth!).

The objective is to demonstrate the breeding and husbandry aspects of fleece production that take place before processing commences. It will provide the opportunity to promote your stock, services and products.

The area will be controlled under The Animal Health 'Animal Gatherings (England) Order 2010. Strict bio-security measures will be in place with all pens at least 5m apart. It is anticipated that animals will arrive in 'stock' trailers and it is required that they are penned around the lowered tail ramp of the trailer using hurdles. The Pen + Tent provides 30 sq meters space.



Space already allocated is highlighted and named. Additional space for exhibits without livestock is available.

Should you have your own marquee / tent / gazebo and wish to utilise the paddock for your display then you can book all or part of Space 'A', 'B' or 'C' up to the maximum available which is shown in the table below. Please complete this form with entering size you need in the 'A', 'B', 'C' column.

Show Passes

Exhibitors will receive **one vehicle pass** and **four Set up / Break Down passes** Valid for **19th August 8am – 8pm** and **21st August 4.30pm – 8pm** and **three Show Passes** valid for **20th and 21st August**.

Set Up / Vehicle Unload Slot.

Livestock should be brought in and the pens set up at 0800 on Saturday to be ready for the 1000 opening. Vehicles may remain hooked to their trailers.

There is adequate parking space for unloading close to the exhibition areas; however we would request that as soon as you have completed unloading you move your vehicle to the general parking area to allow others to unload.
